

#### **Definitions**

- PQL: Practical Quantitation Limit, this is the smallest amount the analyte can be measured at without estimation.
- Blank: A quality control sample that is free of the analyte being measured.
- Positive Control: A quality control sample with a known amount of the analyte used to demonstrate accuracy. The result is often
  expressed as a percent recovery.
- Field Duplicate: A second sample collected in the field using the same sampling method as the primary sample. The purpose is
  to demonstrate that the batch sampled is uniform.
- Action Limit: Analyte levels set by the state of Oregon indicating that follow-up action is necessary.
- Accreditation Status: Indication that the methodology, calibration, and laboratory QC used by PREE Laboratory for an analyte
  has been evaluated by a third-party auditor and determined to be accurate, precise, and selective.
- ppm: parts per million, equivalent to mg/g and mg/L.
- % Rec.: Percentage Recovery = [(Amount measured) / (Known amount)] \* 100
- ND: The sample result is less than the PQL.
